

## GTC Fee Schedule - April 1, 2011 - March 31, 2012

The fees automatically increase each year on April 1 by a factor that is equal to the GNP of the 1st quarter of the previous calendar year divided by the GNP of the first quarter of the year before that. For example, the fee increase effective April 1, 2011 is based on the GNP of the 1st quarter of 2010 divided by the GNP of the first quarter of 2009. The reference for the GNP is taken from the Bank of Canada Banking and Financial Statistics report for December of the year previous to the year for which the fees are being increased. (2011/12 Multiplier = 1.00)
